New Business (22 vote cards counted)

1. 2020 dues increase discussed (first in 15 years): Expenses exceeding revenue, need to add D&O insurance indicated by Bylaws: Votes were unanimous in support of an increase to \$75/year. A second vote in support of an increase to \$100/year was passed by a majority (not unanimously). The board will make a final decision at a future meeting.

- 2. Social events—a discussion about how to increase turnout? Ideas proposed by members included softball games, talent show, campfire sing-a-longs, game night.
- 3. Watercraft storage at beach was discussed. Any cost associated should be collected through rental of spaces. Issue to be explored further in future.
