## Annual Meeting

*The following is a summary of the news from GCC's Annual Meeting held on June 12.*

**Pre-meeting Fun**

Music and tasty food was on the menu for the pre-meeting BBQ this year. Good old-timey tunes were provided by local band Dog Fish Creek and Donna Elena once again manned the grill to feed those who showed up for this important community event.

**Accomplishments**

Board members reported on their duties and accomplishments (as well as some problems) over the preceding year. Highlights included a new public venue for monthly Board meetings (see Board Meeting notice for details), numerous maintenance and repair projects in our parks, an Eagle Scout project that installed a new play structure at the beachfront park, dog poop bag dispensers installed at both parks, monthly cleanup along Gamble Bay Road through our neighborhood, Earth Day community cleanup, and ongoing work with our

lawyer to consolidate and update our legal documents (see special meeting notice).

**Future Goals**

In addition to completing and hopefully passing restated GCC By Laws we will be working with our lawyer to consolidate and restate our covenants (then we can begin looking at updating and improving them).

Motions by members that were discussed and passed include: Installation of horse shoe pits at the beach park (depending on total cost, additional picnic tables were also approved); Purchase and installation of additional aggregate benches around the fire pit; Create an improved pedestrian entry around the gate at the beach park entrance; Investigate adding electrical power to the beach park; Installation of sign to remind drivers into the beach park that children are at play in the area in hopes of reducing traffic speed; Purchase of an official GCC laptop so that member information and records are not kept on private computers; Improvement of the ball field at the beach park.

**Filling of Board Vacancies**

The last bit of business was to fill three Board seats as members Gus Holstein, Phil Elena and Diane Green had terms expire. Gus and Phil offered to serve again and were nominated and elected. Diane decided to decline another nomination after giving much time and energy over 2 years as communications officer.

Tori Dougherty stepped up to volunteer and was elected to fill the fifth Board seat. Tom Moench and Tom Twigg continue to serve existing terms.

## Special Meeting October 20

The GCC Board has been working with an attorney to gather all of the many legal HOA documents that have been created since 1967, consolidate them and restate them so that we have a known base from which to move forward. This summer work on the By Laws was completed—they have been restated (rewritten to be more clear and understandable without changing their meaning) and recommendations have been made by the lawyer for a new amended version with basic improvements (generally eliminating ambiguity and conflicting rules and bringing them up to date). A special meeting is being held to ask members to approve these amended By Laws.

The By Laws are the governing documents of the HOA that describe how the Board is formed, give and limit Board authority and define liabilities. They also state requirements for meetings, notices, processes for approval of rule and dues changes and the like.

**The By Laws are not related to the covenants that define rules about what members may or may not do on/with their properties (to clear up any confusion about this).**

A special meeting will be held at **7:30 PM on Wednesday, October 20, at the North Kitsap Fire & Rescue station** to review, discuss and vote one the recommended changes to the GCC By Laws. (Links to PDF versions of the restated and recommended versions of the By Laws will also be available on the [Gamblewood.org](http://Gamblewood.org) website for review.)

To vote you must be present (or send a proxy with a signed letter from you) and be in good standing (your dues are up-to-date).

After the By Law changes are (or are not) approved the Board will continue working on the next step which involves a similar process with the GCC covenants.

These are important steps that should make it easier for realtors, lenders, and title companies to work with Gamblewood members and home buyers. GCC President Tom Moench has given a lot of his time into getting us to this point—I for one appreciate his efforts and dedication in taking care of what has been a longstanding problem of disparate documents that span decades for our community.

## Do You Know Where Your Dog is?

It is probably an issue in almost every community—loose dogs that poop in your yard, scare your kids, pee in your garden or bark at all hours. A number of members have contacted the Board about this problem and have asked us to address it. The truth is that there is not a lot the Board can do besides remind everybody to try to be better neighbors and keep your animal on a leash or fenced. Grab an extra poop bag or two next time you walk past one of the parks and tie it to your leash so you will always be ready to clean up after your dog. If your dog barks while you are away from home please consider kenneling them indoors.

If you have a problem with a known neighbor's dog, first try a friendly talk to explain the issue. If that fails it may be to time to contact the county. For a barking dog problem call 360-337-5777 to start a complaint, all other types of complaints should call 360-692-6977 ext. 7216. We are at somewhat of a disadvantage here in an unincorporated area of Kitsap so an extra effort to solve the problem between neighbors in a friendly way may pay off in more ways than one.

The Gamblewood Community Club Board is made up of 5 members with staggered terms (one 3 year term, two 2 year terms and two 1 year terms). This past June (2010) Phil Elena, Gus Holstein and Diane Green had terms expire -- Phil and Gus offered to serve again and were re-elected at the annual meeting, Diane chose to decline another nomination after giving much time and energy to the community over 2 years on the Board as communications officer. Tori Dougherty stepped up and offered to take the open seat and was elected to fill the Board's fifth seat.

Board positions are worked out among the Board in a special meeting following each annual meeting. Monthly meetings are usually scheduled on the 3rd Monday of the month and are held at the North Kitsap Fire & Rescue station on Miller Bay Road. The meeting is open to the public from 7:30 - 8:30. ### Tom Moench - President

**Park Seasons**

The gate at the beach park will close on Oct. 15th and will remain locked until April 15th, 2011. As noted in the Annual Meeting summary, a project to improve the park entrance for those on foot was approved so soon ducking under the gate or around onto private property during the winter months will not be necessary.

Those using the park on foot during the winter months are reminded that posted hours

still apply (9 a.m. to 10 p.m.). Late night parties are not allowed and too frequently result in vandalism and litter that is expensive to the community—police will be notified of activity in the park after 10 p.m.
